There will be free seminars on distilling lavender, benefits of lavender, and demonstrations throughout the day in the City Park Gazebo.

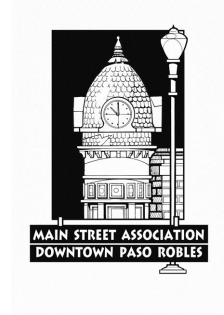

### SET-UP

Set-up will begin at 7 a.m. on Saturday morning. Once you have unloaded your vehicle, promptly move it to the long-term parking lots at the city library on 10<sup>th</sup> Street or city lot at Railroad and 12<sup>th</sup> Streets. Canopies and displays must be fire retardant. Electricity is not available.

**Early breakdown is not permitted & all vendors must remove their own trash.**

Cancellations up to 20 days before the event are subject to a \$35 handling fee. **The space fee is NOT refundable after June 19, 2017.**

### PREPARED OR PACKAGED FOOD/DRINK VENDORS:

If you are selling packaged food items, prepared food/drink, or offering product tastes, your business must have an Environmental Health permit valid in SLO County (call the county at 805-781-5544) and you must **INCLUDE WITH YOUR APPLICATION** a Certificate of Insurance naming Paso Robles Main Street Association, Central Coast Lavender Growers Association, and the City of Paso Robles as additional insured entities on your policy of insurance.

### ARTISTS

**Jury selection:** Each artist's work will be juried based on quality and originality. Only work created by the applying artist will be considered. Please send four (4) photos of your work with application. **Include a SASE with sufficient postage for return of photos and your space map with space assignment.** If you are denied participation in this event you will receive a full refund.

### LAVENDER GROWERS/ VENDORS

Also, all Lavender vendors should have the proper banner signage for their booths. Lavender vendors that are providing items for the public to eat or drink, must comply with Health Department requirements and provide the insurance certificates as stated under #3 on the application form.
