If you are selling prepared food, packaged food items, or offering olive or olive oil tastes, your business must have an Environmental Health permit valid in SLO County (call the county at 805-781-5544) and you must **INCLUDE WITH YOUR APPLICATION** a Certificate of Insurance naming Paso Robles Main Street Association and the City of Paso Robles as additional insured entities on your policy of insurance.

**RETAIL/CRAFT VENDORS**

**Jury selection:** Jury selection: Each vendors work/products will be juried based on quality and originality. Only work created by the applying creator/artist will be considered. **WINE / BEER TASTING**

No space fee is charged to participating wineries and breweries, who pour at no charge. Single-ounce tastes are poured only for adults issued wristbands by Main Street after verifying age eligibility and purchasing a glass and six tasting tickets.. Your business must have an ABC Permit (Main Street will obtain the one-day ABC License on your behalf). Wine/Beer vendors must **ATTACH WITH THIS APPLICATION A CERTIFICATE OF INSURANCE, including liquor coverages, naming Paso Robles Main Street Assoc. & City of Paso Robles as additional insured for May 11, 2024.**
